## **KEY ACTIONS & ACHIEVEMENTS**

#### POST OCTOBER 7 HAMAS MASSACRE

- Proud to lead global legal campaign in support of Israel, victims of the October 7 attacks and hostages who remain in captivity in Gaza.
- Submitted the first war crimes claim in the International Criminal Court arising out of the Hamas massacre of 7th October, 2023.
- Filed federal lawsuit in the U.S. on behalf of October 7 survivors, against UNRWA USA over complicity in Oct 7 attacks, and assisted partners in Canada, to take the federal government to court over resumption of UNRWA funding.
- Filed lawsuit against leading cryptocurrency company Binance over role in allowing their platform to be used by Hamas and Islamic Jihad to fundraise for Oct 7.
- Supported lawsuit by colleagues against Associated Press, over use of Hamasaffiliated photographers during the Oct 7 attacks.
- Stood up for Israel at The Hague, against the baseless charges of 'genocide' at the International Court of Justice.
- Together with WZO, produced one of the first FAQ Reports on International Law and the war with Hamas. The report, distributed widely around the world, also included a series of educational videos.

#### **BEFORE OCTOBER 7 HAMAS MASSACRE**

- Spearheaded legal campaign to have Unilever reverse Ben & Jerry's boycott, including initiating one of the first legal actions against Unilever.
- Stood up for students on campus, by filing the first legal proceedings against UC Berkeley Law School, over the discriminatory and antisemitic decision to exclude Zionist speakers, as well as initiating a campaign for IRS to revoke CUNY's tax-exempt status over systematic antisemitism and support for BDS.
- In a major victory, successfully stopped online financial donations to a major charity, which was serving as fiscal sponsor to the Palestinian PFLP-affiliated terror group, Samidoun.
- Blocked transfer of over \$25 million from Europe to Palestinian terror groups, such as PFLP, and their affiliates.
- Led response to 'apartheid' allegations by Amnesty and HRW.
- Successfully led the legal campaign to have AirBnB reverse the boycott of Judea & Samaria.
